## Become a Donor of the Global Marshall Plan Initiative!

By becoming a donor you are helping us to cover expenses, which accumulate while coordinating and creating awareness for the initiative.

### Contributions

Annual donor Rates have 5 levels, which are based on annual turnover (revenue, budget, members or employees) of your organisation as follows:

Annual turnover, revenue, budget (in million €), members or employees	Global Marshall Plan annual Registration fee (in €)

100 – 1,000	5,000
10 – 99	500
2 – 9	200
< 1	50

It is possible to increase your donor fee if you wish to contribute more. Simply fill out the desired additional amount in the appropriate field of the donor application form. Persons and Organisations from developing countries have the possibility of paying a reduced donor fee.

After receipt of your registration and payment for this year the Global Marshall Plan Foundation will begin debiting the yearly fee from your account every January. You will receive a yearly confirmation of your donation for the entire sum to present to your local tax authorities (only possible in Germany).

#### Information on Tax Deductions in Germany

For donations to foundations you can claim up to an additional €20,450 in yearly tax deductions (applies to income, corporate body and trade taxes, § 10b Abs. 1 Satz 3 EStG, § 9 Abs. 1 Nr. 2 Satz 3 KStG, § 9 Nr. 5 Satz 3 GewStG).

#### 2. Leave Your Mark – Become a Founder of the Global Marshall Plan Foundation

Currently, the Global Marshall Plan Foundation, Rissener Landstrasse 193, 22559 Hamburg, Germany, owns a 26% share (valued at €150,000) of an Enercon wind energy plant near Erfurt, Germany, which is producing an average annual profit of €25,000 for the work of the Global Marshall Plan Initiative. As a founder your donation will always remain part of the foundation capital and only the annual interest will be added to the budget used to support the activities of the Global Marshall Plan Initiative.

#### Information on Tax Deductions in Germany

In addition to your other contributions you can, as a co-founder, deduct up to 307,000€ worth of capital stock on your income tax declaration in the year of allowance and the following nine years and thereby reduce your tax payment; as a founder you can claim this amount only once in ten years (applies only to the income and trade taxes § 10b Abs. 1a EStG).

We can also gladly consult and support you with the formation of your own dependent foundation in your name, which would carry out the complete administrative duties of the foundation for you. The unearned interest of your foundation is applied yearly to the work of the Global Marshall Plan Initiative.
